The Ohio Department of Public Safety has reviewed your report of investigation and your subsequent recommendations. Following is a summary of our response to those recommendations.

1. ODPS-OIU should conduct an administrative investigation into the actions of AAIC Tatter to determine any discipline or training needed.

RESPONSE: An administrative investigation was initiated on September 12, 2011, following the release of the Inspector General's report that same day.

2. ODPS-OIU should review with the residency policy with employees to assure compliance. It is noted that during the course of this investigation, the OIU revised the residence policy.

RESPONSE: On May 1, 2011, and prior to the release of the Inspector General's report, the revised policy "Residency Requirements/Travel Time (INV 100.05)" was distributed to all sworn OIU personnel. The policy was redistributed on October 21, 2011.
